LCR Continues DADT Fight at Ninth Circuit

Log Cabin Republicans have filed a response to the Obama administration's latest attempt to indefinitely delay arguments in *Log Cabin Republicans v. United States*, despite legislation enacted last month which removed DADT from U.S. code.

The military has emphasized that the policy remains in force and the Obama Department of Justice continues to defend the ban in court.

"Log Cabin Republicans are acutely aware President Obama and his administration desperately want our case to just go away. That is not going to happen," said Log Cabin Republicans Executive Director R. Clarke Cooper. "The Obama administration's continued defense of this failed and unconstitutional policy is a mystery. DADT was rejected by Congress, by the Joint Chiefs of Staff, and most notably, by the American people. It is time for the President to stand by his commitment and end this

policy of discrimination, removing the threat and specter of discharge from thousands of patriotic servicemembers."

The repeal of DADT is not yet effective and DADT will likely remain the law of the land until the end of 2011. In the meantime, openly gay individuals are not free to enlist in the armed forces, current servicemembers must continue to live a lie and the government continues to investigate and discharge servicemembers under DADT.

"At the same time, the government is trying to delay the

UCC Nominates First Out-Gay Pastor To Top Denominational Post

The United Church of Christ has nominated its first out-gay candidate to serve the 1.1-million-member denomination as one of its top elected national officers.

The Rev. J. Bennett Guess, 44, was selected by a search committee to serve as a member of the UCC's five-person Collegium of Officers and to head Local Church Ministries, one of the church's four national bodies.

Guess' selection must be affirmed by a board of directors in April, before his name is put forward for election by 1,000 delegates attending the UCC's biennial General Synod, July 1-5, in Tampa, FL.

Guess, who presently directs the UCC's publishing, identity and

communication ministry, has been a member of the denomination's national staff for more than a decade and has been active in LGBT activism throughout his ministry. As the UCC's lead communicator, he has been an active member of the National Lesbian and Gay Journalists Association.

In 1993, while a pastor in Henderson, Ky., a city of 27,000 near Evansville, Ind., Guess helped

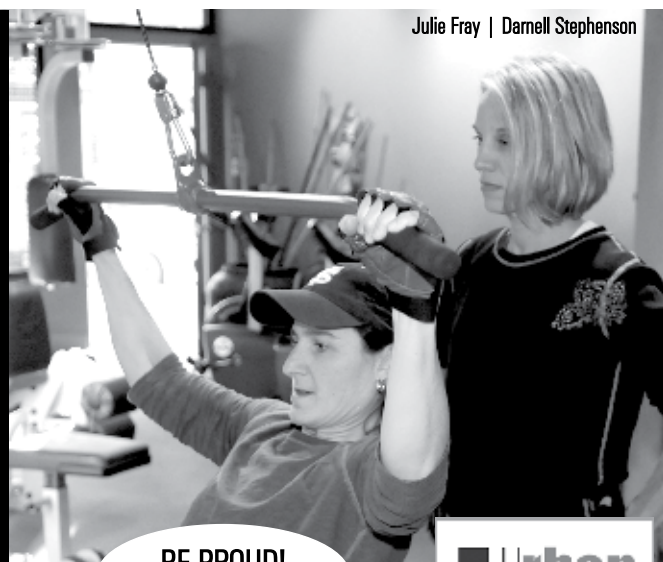

DOJ Files Brief Supporting DOMA

Attorneys for Obama's Justice Department have filed a court motion in support of the Defense of Marriage Act, despite the President's evolving view that the law should be repealed.

Saying that it is obligated to defend U.S. policy, regardless of the president's personal beliefs, the Department filed a brief on January 13 before the U.S. Court of Appeals for the First Circuit in defense of the law after a lower-court judge ruled it unconstitutional.

The filing of the brief drew immediate criticism from LGBT rights organizations, including Freedom to Marry.

"We regret that the Department of Justice continues to defend a law that President Obama has repeatedly said is discriminatory," said Evan Wolfson, Executive Director of Freedom to Marry, "a law that the Republican Congressman who sponsored it back in 1996, Bob Barr, and the Democratic President who signed it, Bill Clinton, now agree should be repudiated."

The Defense of Marriage Act defines marriage as a union between a man and woman. Despite the President's questioning of the law, and new national polls that show Americans no longer support it, the DOJ attorneys in their brief stated that the law was



"not unconstitutional under this court's binding precedent," and argued that the law "reflects Congress's reasonable response to this still-evolving debate among the states regarding same-sex marriage."

"Indeed, the president supports repeal of DOMA and has taken the position that Congress should extend federal benefits to individuals in same-sex marriages," attorneys said in the brief. "But a consensus behind that approach has not yet developed, and Congress could properly take notice of the divergent views regarding same-sex marriage across the states."

The brief was filed in the cases *Nancy Gill v. Office of Personnel Management*, brought by Gay & Lesbian Activists & Defenders (GLAD), and *Massachusetts v. Department of Health and Human Services*, brought by the state.

Led by Assistant Attorney General Tony West, the DOJ argues that U.S. District Court Judge Joseph Tauro in Boston erred last year in finding one section of the federal DOMA unconstitutional and that "back-and-forth changes" such as those experienced by California concerning the recognition of same-sex marriages "have the potential to cause inequities in the operation of federal programs, and could result in administrative difficulties across a variety of federal programs."

"It is disappointing that the Justice Department is urging the court to give this discriminatory law a presumption of constitutionality," said Wolfson. "At a minimum, laws that carve out Americans because of race, sex, religion or sexual orientation should be presumed unconstitutional, and should get heightened scrutiny by the courts. The Justice Department should be asking the courts to examine DOMA with skeptical eyes, not rubberstamping discrimination."

A three-judge panel of the First Circuit U.S. Court of Appeals in Boston will hear the cases later this year. Regardless of their decision, the cases are expected to be argued before the U.S. Supreme Court.

Brown's Budget Imposes Cost-Sharing on People with AIDS

According to analysis provided by Project Inform, Governor Brown's new budget proposal provides an additional \$77.2 million for the AIDS Drug Assistance Program (ADAP) to address growing need, but would institute cost-sharing for ADAP clients that may be burdensome.

ADAP provides access to lifesaving HIV medications for over 35,000 low-income Californians living with HIV/AIDS who are uninsured or underinsured.

The details regarding the amount of cost-sharing and how it will be imposed have not been decided, but research indicates that even nominal co-pays can present a real barrier to low-income people accessing their lifesaving medication.

"We thank Governor Brown for providing sufficient funding to ensure that California's ADAP continues to meet the needs of low-income people with HIV/AIDS during this unprecedented fiscal crisis," said Anne Donnelly, Director of Health Care Policy. "However, we are concerned about the impact of co-payments on ADAP clients. We know that cost-sharing can create real barriers to treatment access and could result in people not getting the medications they need to stay healthy and productive. We also know that the same people who depend on ADAP for a lifesaving but limited formulary of drugs have additional, substantial cost sharing in the rest of their medical care.

"Stable access to HIV treatment and care is vital to achieving the treatment and prevention goals of President Obama's National HIV/AIDS Strategy. We look forward to working with the Governor and the State Legislature to identify alternative ways of saving money in ADAP that do not disrupt people's ability to access their medications."

Project Inform also expressed concern about proposed cuts to Medi-Cal and other programs serving low-income Californians. Medi-Cal proposals to limit prescription drugs and doctors visits, impose cost sharing on low-income people and lower provider rates combined, would significantly erode California's health care safety net.

"Cutting payments through Supplemental Security Income/State Supplementary Payments (SSI/SSP) from \$845 per month to \$830 per month will make choices between rent, food and medication even more difficult for some of the most vulnerable Californians," said Donnelly.

Finally, cuts to In-Home Supportive Services (IHSS) may result in fewer disabled people being able to stay in their homes.

Many people with HIV/AIDS rely on these programs for their health care and other needs. Medi-Cal plays a particularly important role for people with HIV, serving almost half of HIV positive Californians, with up to 70 percent of uninsured HIV positive individuals expected to become eligible for the program when health care reform is fully implemented in 2014.

"Due to severe budget deficits in the last couple of years, the Medi-Cal program has already suffered serious cuts, including adult dental services and vision services," continued Donnelly. "Further cutting the program seriously deteriorates this essential health safety net. This is the same program that as many as 70 percent of uninsured HIV positive Californians will depend on for comprehensive and quality health care coverage under health care reform in 2014.

Project Inform said that they will work with their advocacy partners, the State Legislature and the Brown Administration to develop proposals that recognize the state's severe fiscal crisis while ensuring that people with HIV/AIDS have full access to health care and treatment.

"Californians must take a stand that balancing the budget based on cuts to the most vulnerable among us is unacceptable and we must urge our elected officials to seek responsible revenue sources to maintain life-saving programs," said Donnelly.

LGBTs Targeted for National Suicide Prevention Efforts

The National Action Alliance for Suicide Prevention has added three new task forces to address suicide prevention efforts within high-risk populations: American Indians/Alaska Natives (AI/AN); youth who identify as lesbian, gay, bisexual, or transgender (LGBT); and military service members and veterans.

This brings to six the number of task forces formed by the Action Alliance, the public-private partnership forged in September to advance the National Strategy for Suicide Prevention (NSSP) (www.actionallianceforsuicideprevention.org).

"I am heartened that we are focusing attention on communities hardest hit by suicide. By shining a

light on their struggles, I am optimistic we can help them identify solutions and bring hope for a better tomorrow," said Gordon H. Smith, co-chair of the Action Alliance. Smith, a former U.S. senator who championed passage of the 2004 Garrett Lee Smith Memorial Act following the loss of his son to suicide, now serves as President and CEO of the National

Association of Broadcasters.

In the U.S., suicide claims over 34,000 lives annually – the equivalent of 94 suicides per day, or one suicide every 15 minutes.

State and local prevention efforts are having a positive impact as rates of suicide have been falling among teenaged and elder males, two of the hardest hit groups. Suicides are increasing among other groups, however, such as AI/AN youth and military members.

Studies from organizations such as the Suicide Prevention Resource Center report that lesbian, gay, and bisexual youth are from 1.5 to

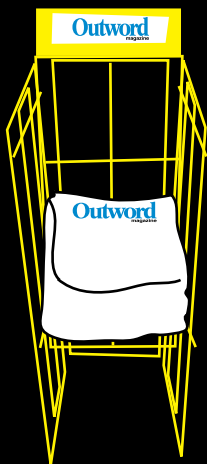

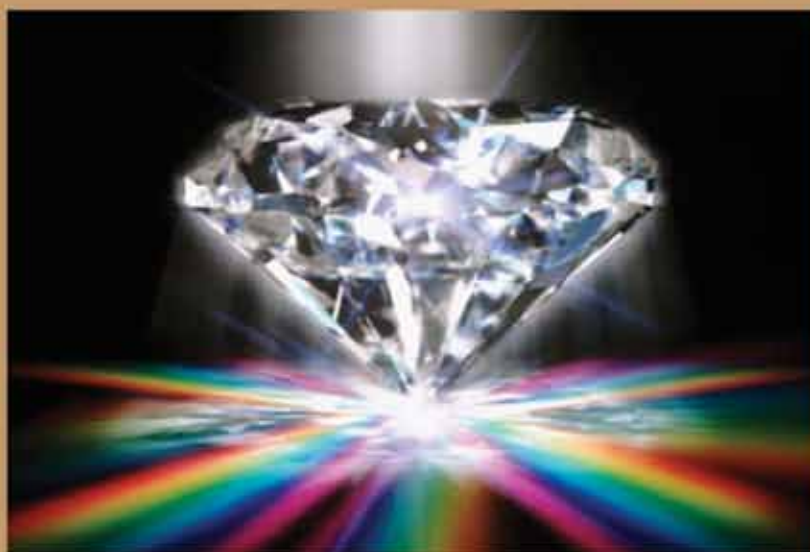

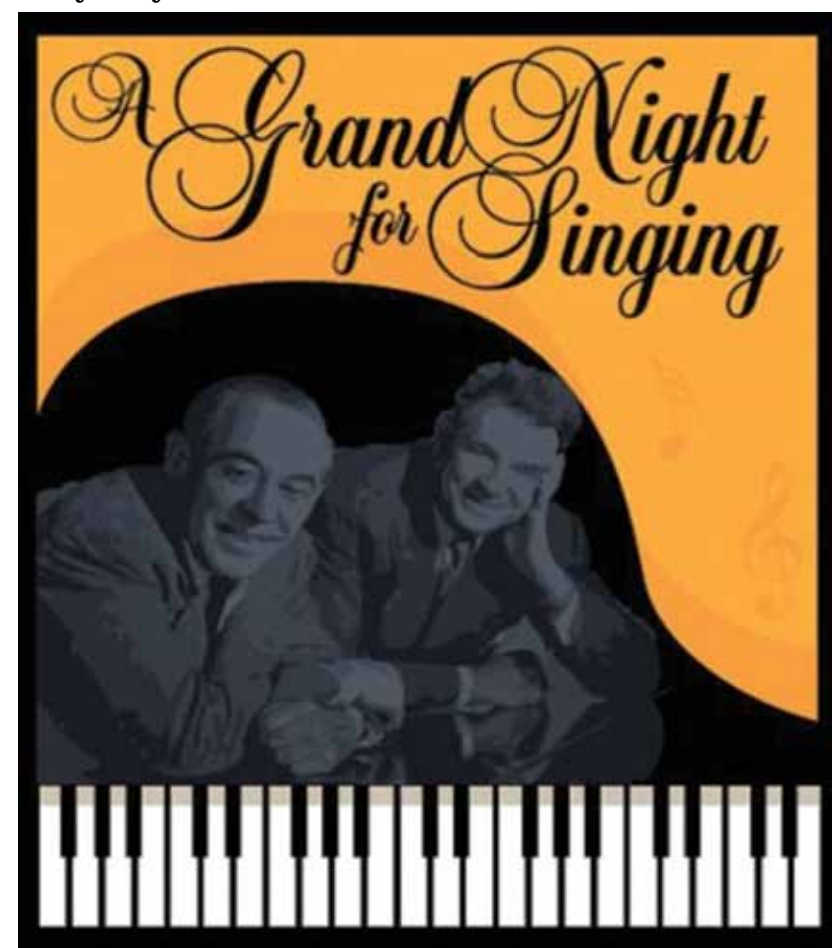

Lucky Lady comes to DVD Plus Conviction and Catfish

Two very different but equally intriguing titles make their way to DVD on February 1. A third film was released on DVD in early January, but I still can't get it out of my head.

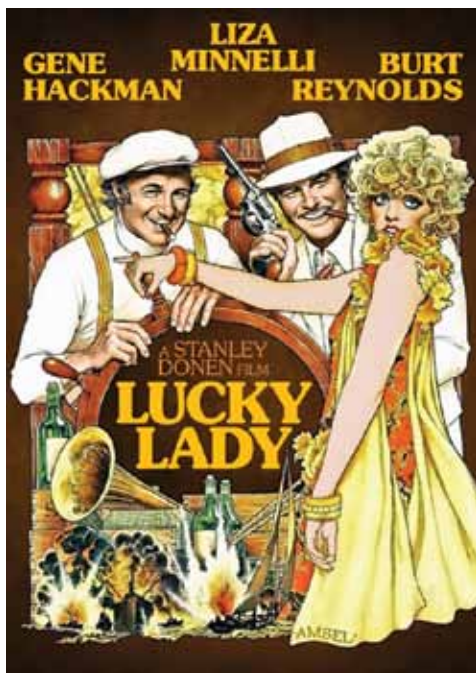
Lucky Lady

This all-star comedy from 1975 stars Liza Minnelli, Gene Hackman and Burt Reynolds at the height of their stardom in an homage to the screwball comedies of the 1930s. This type of humor is difficult to pull off, and *Lucky Lady* was a notorious bomb for director Stanley Donen, the genius behind *Singin' in the Rain*.

Thirty-five years later, in 2010, *Lucky Lady* looks like a classic compared to most of what passes for comedy these days. It's not Shakespeare, but the three leads make a unique ménage a trois of bootleggers in this prohibition-era story by the writers of *American Graffiti*. Available February 1.

Conviction

This Oscar-bait drama from last fall didn't do well at the box office,

but it deserves a second look, especially for its talented cast.

Hillary Swank, Sam Rockwell, Minnie Driver, Juliette Lewis and Peter Gallagher turn in top-notch performances in this "based on a true story" tale of a courageous woman (Swank) whose 18-year quest sought to clear the name of her wrongly-accused brother.

The real-life heroine even put herself through law school in an effort to set the record straight. Available February 1.

Catfish

This gripping film arrived on DVD on January 4, and it's billed as a reality thriller, which isn't far off.

A true-life tale of online intrigue and deception fuels this surprisingly suspenseful cinematic story by filmmakers Ariel Schulman and Henry Joost that was inspired by the life of Schulman's brother, Nev.

I don't want to give anything away, but if you are a fan of "stranger than fiction" films, this movie is definitely for you.

briefing and argument on its appeal from the judgment and injunction obtained by Log Cabin Republicans,” said Dan Woods, partner at White and Case who filed the law suit. “The government asked us to agree to the delay and we were willing to do so, on one condition: that the government halts all pending investigations and discharges during the period of delay.

“The government refused and its attorneys said that investigations and discharges will continue. For these reasons, Log Cabin Republicans’ case is still alive and kicking.”

LCR is opposing the government’s motion to delay the appeal and asking the U.S. Court of Appeals for the Ninth Circuit, in the alternative, to stay all investigations and discharges in the event it is

prepared to grant the government’s request for delay.”

Log Cabin Republicans have maintained a three-front strategy against DADT, lobbying for repeal in Congress, consulting with the Department of Defense, and filing suit in federal court. The case went to trial in July of 2010, and Judge Virginia Phillips ruled on September 9, 2010 that the policy violated the First and Fifth Amendments of the Constitution.

co-found the Kentucky Fairness Alliance, the state’s LGBT advocacy organization which he co-chaired for five years.

In 1996, Guess’ congregation formed Matthew 25 AIDS Services, a comprehensive federally-funded HIV/AIDS clinic that continues to serve clients throughout southern Indiana and western Kentucky.

In 1999, Guess successfully led a grassroots campaign to add sexual orientation to the city of Henderson’s non-discrimination policy, a measure adopted then repealed by the city’s commissioners just three years later.

While Guess would be the first out-gay person to lead the liberal

denomination, the UCC, with 5,300 churches nationwide and the largest Protestant church in New England, is well known for its support of gay rights.

The church was the first to ordain an openly gay pastor in 1972 and the first to affirm same-gender marriage equality in 2005.

seven times more likely to report having attempted suicide than their non-LGBT peers, while transgender youth are believed to have higher rates of suicidal behavior as well.

Co-leading the LGBT Youth Task Force are Kevin Jennings, Assistant Deputy Secretary, Office of Safe and Drug-Free Schools, U.S. Department of Education, and Charles Robbins, Executive Director of The Trevor Project, the leading national organization focused on crisis and suicide prevention efforts

among LGBT youth.

“This task force will bring together the best minds in the country to combat suicide and make sure that every LGBT youth has the opportunity to grow up in a supportive, accepting community and to enter adulthood safely,” Robbins said.
