

## Matsui Asks for Insight on Homeland Security Policies on LGBT Issues

Dear Outword,

I want to update you on two recent letters I co-signed with a number of my colleagues.

One letter, addressed to Secretary of State Hilary Clinton, acknowledges the State Department's leadership in responding to human rights abuses targeting LGBT individuals.

The second letter, addressed to Secretary of Homeland Security Janet Napolitano and Attorney General Eric Holder, highlights concern for the mistreatment of LGBT immigrants while in the federal government's custody.

In a June speech, Secretary Clinton reaffirmed the State Department's commitment to the worldwide LGBT community. During her speech, Secretary Clinton announced that the State Department's regional bureaus will continue to work closely with their U.S. embassies to ensure all human rights are protected.

Energized by this address, several of my Congressional colleagues and I sent a letter to Secretary Clinton requesting that she highlight some of the ways in which they plan to continue this crucial human rights mission.

Specifically, we requested that the State Department inform us on how they plan to prepare diplomats to conduct public engagements surrounding LGBT issues and provide us more information regarding their efforts to provide emergency aid to human rights defenders.

The letter to Secretary Napolitano and Attorney General Holder, emphasized concerns about the reports of sexual abuse and denials of medical care to LGBT immigrants while in the custody of the Department of Homeland Security (DHS).

We urged Secretary Napolitano and Attorney General Holder to conduct an immediate investigation in response to the alarming abuse allegations.

As you are well aware, I strongly believe in human rights and will continue to support the LGBT community through my work in Congress.

# Petition Gathering to Overturn FAIR Education Act OK'd

The Capitol Resource Institute has received approval from the Secretary of State's office to circulate petitions for a referendum on the June 2012 ballot that asks voters to overturn SB 48, the FAIR (Fair, Accurate, Inclusive, and Respectful) Education Act signed into law by Governor Jerry Brown in early July.

The group has until mid-October to collect more than 504,000 signatures to qualify the measure for the ballot. CRI is headquartered in Sacramento. Their web site does not list any officers.

The FAIR Education Act requires that LGBT Americans and people with disabilities are included and recognized for their important historical contributions to the economic, political and social development of California.

It adds both groups to the existing law that requires schools to include underrepresented groups, including women and people of color, in textbooks and other instructional materials. It also prevents the adoption of materials that discriminate on the basis of sexual orientation, disability or religion.

"California has a long legacy of leading the nation on issues of inclusion and justice and the FAIR Education Act represents the next

step in that tradition," said Roland Palencia, Equality California Executive Director. "This attack on the FAIR Education Act isn't just an attempt to censor the contributions of LGBT people and people from the history books, it's also an attempt by our opponents to revive lies based on prejudice about LGBT people being dangerous to children."

In a joint statement from EQCA and the Gay-Straight Alliance Network, the groups announced that over the coming months, they are prepared to prevent the measure from reaching the ballot by engaging Californians in a

conversation about our opponent's real motivations and the truth about what the FAIR Education act does and does not do.

Research shows that in schools where LGBT people are included in classroom discussions, students are 50 percent less likely to report being bullied. The FAIR Education Act is intended to ensure that all students in California receive a fair and accurate account of California's history, including the contributions of women, people of color, LGBT people, people with disabilities, and other historically underrepresented groups.

Karen England, executive director of Capitol Resource Family Impact, an arm of Capitol Resource Institute, said on CRI's website that reaction to the FAIR Act "has been like nothing I've seen - the outrage, the interest nationwide has been very positive to our side of things."

"Sadly, throughout history, conservative groups have tried to exclude the contributions of these

communities when they haven't suited their political agenda," said Carolyn Laub, Executive Director of Gay-Straight Alliance Network. "We trust that Californians will continue to support an honest education that does not erase the LGBT community and its accomplishments from history."



# A Career As a Lobbyist Can Help Make a Difference

As the nation breathes a sigh of relief that a truce between the major political parties lasted long enough to avert a U.S. government default and potential economic crisis, Sacramento lobbyist Rand Martin hopes young people seeking to begin a career in government will follow a kinder, gentler path than their political elders.

"The first thing I would say to a young person who is interested in a career in government service is, 'More power to you,'" Martin says. "There's a great need for interested, committed, passionate young people to engage in the political process."

Key to a successful career in government service, Martin continues, is the ability "to acknowledge there's not just one story or view of a particular policy issue."

"It really bodes ill for the body politic to have people who won't listen to their opponents' views," he says. "The people who do listen, who seek to accommodate and find solutions rather than seek ways to express empty rhetoric or hype will be the most successful and do the most for the people of California and this country."

Although Martin says he more or less stumbled upon his own career path, he has been fortunate to be able to turn his passion for public service and helping others into a successful career at the State Capitol.

"I was doing theater when I got out of

college, which is the last time I ever earned money to support myself through theater. When I moved back to California after living in Virginia, I realized I needed to have a job if I wanted to stay." In 1985 he accepted a position as lobbyist for the Association for

than 100 organizational members.

After leaving LIFE, Martin went to work for L.A. Assemblymember Terry Friedman, who would go on to become a Superior Court Judge, then for State Senator John Vasconcellos, where he served until 2001.

After leaving Vasconcellos' office, Martin joined the lobbying firm, Rose & Kindel, where he represents a variety of interests. In 2002 he added the Los Angeles-based AIDS Healthcare Foundation to his client list, the world's largest provider of AIDS healthcare services, with a presence in 22 countries, and the largest private HIV testing provider in

drug user populations. The second would seek additional funding for people living with HIV and AIDS as Medi-Cal clients are moved into managed care plans under the federal health care reform bill.

In his early Sacramento years, Martin was active in the now-defunct non-partisan political action committee CAPPAC and the River City Democratic Club, precursor to the Sacramento Stonewall Democrats. "One of the things I find from family life is that there is less and less time to do those types of things," he says. Martin and his domestic partner have raised his partner's biological daughter, Lisa, since she was seven.

Martin does find time to revisit his theatrical roots, though. Once active with Sacramento's Lambda Players, he currently works with the Davis Musical Theater Company, where he serves on the board, directs and occasionally performs and is directing their production of *Damn Yankees*.

As for where his career path will lead him next, "I still see myself doing government relations, either inside or outside of the Capitol," he says. "Knowing the system, knowing the people, having relationships, having good solid legislation and having credibility with people who are pulling the political levers. I don't know whether I will be lobbying forever, but I'm pretty well convinced I will be doing something in government relations."

Retarded Citizens. "At the time, I said 'I'll give Sacramento a couple of years, then go back.' My home is Sacramento now, not L.A."

Shortly after leaving the Association for Retarded Citizens position, Martin founded and served as executive director of LIFE, the first statewide association of AIDS organizations in the nation. In his four years at the helm, the organization grew to more

the state.

Currently he's working on behalf of AHF on two pieces of legislation, both authored by Anthony Portantino (D-La Cañada.) The first would eliminate the requirement that community-based testers, such as those who staff AHF's four mobile testing vans, obtain a signature – a requirement that can present an obstacle to testing among poor and illegal

# Gay Marriage Opens New Career Path for Gay Wedding Singers

With New York becoming the sixth state to legalize gay marriage, new business opportunities for florists, wedding planners, and club artists are opening up – including for many singers who are now moonlighting as gay wedding singers.

“Weddings are big business,” confirms Kristine W who ranks as one of today’s most popular gay club artists. She has had sixteen #1 dance singles – only Madonna and Janet Jackson have had more. “My highest paid private performance was at a wedding for the daughter of the late Kerry Packer, one of the wealthiest men in Australia. He flew my whole Vegas show over to England.”

Weddings are proving a profitable subsidy for club artists who have been struggling with decreased record sales (due to internet music pirating) and club bookings (due to the weakened economy).

“Clubs used to bring artists in every weekend,” laments Miss W. “Now they book artists once a month and offer smaller fees.”

She says it’s even worse for the

support team behind the artist. “They (clubs) have stopped bringing in back-up singers and dancers. They’re not paying for sound people. Some bookings don’t include hotel accommodations.”

“The business has shrunk, but if you don’t adapt, you will be sitting home,” she warns.

It’s not just about the money for some artists. Out hip-popper Aiden Leslie looks forward to performing his first gay wedding “for the simple reason that it is exercising our equal rights,” he says.

He feels his track, “Worlds Away,” is a perfect gay wedding song because “it is about putting the past behind you, looking toward the future and knowing that anything is possible.”

based club artist, Sariah, has been performing gay weddings since they were legalized in her state seven years ago. She is best known for her club hit, “All About Sex,” but it’s her single, “Believe in Me,” that is most requested at nuptials. “It’s the story of two lovers meeting and learning to build and believe in their love together.”


“The main difference between performing a gay wedding verse a straight one, is the underlying accomplishment felt by all,” she says. “There is a certain shared pride that we have fought to make this happen. It makes the celebration that much more celebratory.”

In addition to New York and Massachusetts, gay marriage is legal in Connecticut, Iowa, New Hampshire, and Vermont. Washington DC and the Coquille Indian Tribe in Oregon also allow gay marriage.

In addition to performing gay weddings, club artist Lala sees opportunity in creating music specifically for gay weddings. “As a songwriter and singer, I look to current trends to influence my work. I’m currently in the studio working on new tracks that talk about same sex marriage.”

In the meantime, she says her club hit “I Love My Sex” is surprisingly appropriate for gay weddings. “It’s about boys loving boys and girls loving girls, appreciating their same gender for all its beauty.”

“What better way to show appreciation for your gender than to marry it?”

# Faith Matters: Room for Everyone

Perhaps the single, most inclusive verse in the Bible is Galatians 3:28. As a Christian, Paul writes to the developing Galatian Christian community that in Christ there are no arbitrary distinctions.

There are no national or racial distinctions, no slave/free, no male/female, but all are one in Christ.

I like this translation: “In Christ there is no national orientation, no ownership orientation, no sexual orientation – you are all one.”

According to St. Paul, there is an essential unity transcending all discrimination.

In AD 45, when he was writing his letters to help guide and encourage new churches, Paul believed that all of us were created heterosexual, and he legislated on the basis of that false assumption.

In his famous chapter on the nature of love (I Corinthians 13) he taught that our knowledge was imperfect and there would come a time when it would fail. He would be very surprised to hear that these letters would become the “Word of God” and unchangeable Holy Writ.

However, they were only pastoral letters from an early apostle; Paul understood Jesus to be the “Word of God,” NOT what he was writing.

If he were in America today, Paul would have graduated from Yale or Harvard. He would be aware of the latest research in psychology and

psychiatry. He would understand the genetic links to our sexual orientation, and he would write differently.

His words in Romans I about men committing “shameful acts with other men” were based on a false assumption: that heterosexuality was common to all. Scientifically, we know this is not true. In fact, our sexuality ranges on a spectrum from male to female, with everything in between.

For Paul, the most important value was love. Recently, when a gay soldier saved lives in his company on the battlefield, people formerly opposed to the gay community suddenly became supportive.

# Few Workers Have Access To Health Benefits For Same-Sex Partners

The Bureau of Labor Statistics has released data on employer-provided domestic partner benefits, showing that 30 percent of civilian employees (private sector, state and local government employees, but not federal government employees) have access to health benefits for same-sex domestic partners.

Similarly, 25 percent have access to health benefits for different-sex domestic partners. State and local employees (33 percent) have more access to health benefits for same-sex partners than do private sector employees (29 percent).

The data is from the National Compensation Survey (NCS), which collected data on the employment benefit policies from more than 15,000 employers in the public and private sectors. The new questions added this year to the NCS will provide annual measures of employees' access to benefits for unmarried domestic partners.

The report shows that employees

were more likely to have access to domestic partner benefits if they worked full-time or had a union contract. Those who worked in the public sector and for larger

show that 70 percent of employees still do not have access to health care benefits for same-sex partners," said Williams Institute Executive Director Brad Sears. "And while the report leaves out federal employees, including over two million civilian employees, they are also not provided health benefits for same-sex partners."

When looking at survivor benefits in defined benefit plans, half of state and local government

companies were also more likely to receive these benefits.

Those who worked part-time, in a service job, or in the South or North Central regions were less likely to receive these benefits.

"While encouraging, these data

employees can name an unmarried partner, while less than 10 percent of private sector employees can do so. The difference is largely due to the fact that very few private sector employers offer defined benefit retirement plans.

# Expedited Hearing Date in Prop 8 Trial

The Supreme Court of California has announced that the hearing date for *Perry v. Brown* will be on Tuesday, September 6, 2011 at 10 a.m., the first day of the court's fall calendar.

The court will hear oral arguments on a question of whether under state law proponents of initiatives have standing to defend their initiatives when they are challenged in court. The question was certified to them

by the U.S. Court of Appeals for the Ninth Circuit earlier this year.

"I am very pleased that the Supreme Court of California calendared our case for the first day of their fall session," said Chad Griffin, American Foundation for

Equal Rights (AFER) Co-Founder and Board President. "The governor and attorney general of California - and the United States District Court - all have found Proposition 8 unconstitutional. now one step closer to seeing the dark walls of discrimination finally crumble."

In a separate, but related matter – the U.S. District Court for the Northern District of California will hear AFER's motion on August 29, 2011 requesting that the video recordings from their January 2010 trial be released to the public.

The report finds that evidence of employment discrimination against LGBT people has been consistently documented over the past forty years in both the private and public sectors. In particular, it focuses on studies that have been conducted since 2005 and presents new data documenting discrimination from the 2008 General Social Survey (GSS), a national probability survey representative of the U.S. population.

Results from the 2008 GSS provide recent evidence of discrimination from one of very few national probability surveys that have collected data about sexual orientation and workplace discrimination. Among LGB respondents to the survey, 42 percent had experienced employment discrimination at some point in their lives, and 27 percent had experienced employment discrimination just during the five year period prior to the survey.

GSS data further show that employment discrimination is more common among LGB employees who are open about their sexual orientation in the workplace than among those who are not—38 percent of employees who are out in the workplace had experienced discrimination in the five year period prior to the survey, compared with 10 percent of those who are not out.

"This new data shows that it's still risky to come out about being LGBT in the workplace," says study co-author Christy Mallory, Legal Fellow. "Therefore, it's not surprising that the GSS data also show that one-third of LGB employees are not open about their sexual orientation to anyone at work."

These results are consistent with findings from other recent studies that reveal a continuing pattern of employment discrimination against LGBT people. In several studies from 2010 and 2011 that report data on transgender people separately, the rates of discrimination are even higher.

"Recent studies show that pervasiveness of discrimination against transgender people in the hiring process," says Williams Institute Executive Director Brad Sears. "The devastating results of this discrimination are confirmed by the high rates of poverty and unemployment documented in the transgender community."

Love is what matters in situations of life and death, and if this is true on the battlefield, it is also true in everyday life. Paul said that if we did not have love, we would be nothing, and all the great religions teach that God is love.

The Bible is a library of 66 books. Each is to be interpreted within its context, separately. Lumping them together and calling them the "Word of God" is inappropriate.

The individual books remain what they always were: letters, poetry, songs, myths, laws, parables, stories, historical accounts and pastoral letters. Their authors wrote from different perspectives, and as St. Paul writes, "We see but through a glass darkly."

When Jesus saw the shortcomings in Jewish Scripture, he initiated radical changes that challenged the establishment and made unconditional love the standard for human relationships. This is still our challenge today!


